In spite of what the Chamber Board says; it is about the money. What do they know about ethics as they have none.</p> <p>The City of Rockaway Beach offered the Chamber three different contracts, which they systematically rejected. She is not upholding the overall goals of the Comprehensive Plan designed to govern city staff, City Council, Planning Commission, development proposals and in establishing land use planning involving citizen input and open meetings.</p> <p>It is our concern that Ruth Daughterty is 1.) subverting citizens input in public meetings and 2.) is financially enriched by a landlord/tenant relationship with a key city staff member.</p> <p>STATEMENT OF JUSTIFICATION OF HER COURSE OF ACTION:</p> <p>I always put the best interests of the citizens of Rockaway Beach ahead of the interests of any individual or organization when voting on issues. I absolutely support the Comprehensive Plan, Charter, Ordinances and Resolutions of our city.</p> <p>Accusation: "Subverting citizens input in public meetings". Fact: The mayor controls public input not any councilor. I value the input of all citizens.</p> <p>Accusation: "Financially enriched by a landlord/tenant relationship with a key city staff member." Fact: For years a city staff member rented a small display space in my shop for \$65 per month which is less than the ethics board requires reporting. Currently, she and her business partner rent space in my building for their own shop.
