Set 1 1/2" x 36" galvanized iron pipe with 3" bronze cap marked "OREGON STATE BOARD OF FORESTRY T2S R9W S28 S27 S33 S34 1959 RS401", 33 inches in ground, in mound of stone, and from which a:

2 1/2" Spruce bears S55E 72.2 ft.; scribed T2S R9W S34 BT. RS401

3 1/2" Alder bears N55E 27.4 ft.; scribed in bark T2S R9W S27BT.

4 1/2" Hemlock bears N81 1/2 W 87.0 ft.; scribed T2S R9W S28 BT.

2 7/8" double Hemlock bears S57 1/2 W 57.1 ft.; scribed T2S R9W S33 BT.

Oregon State Board of Forestry metal location poster on 4 1/2" Hemlock BT.

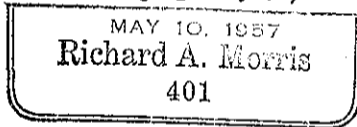
Set 4" x 4" x 60" white painted Cedar post 1.0 Ft. S.W. of pipe.

State of Oregon  
County of Tillamook

I, Harold Williams, of Bay City, Oregon,

being first duly sworn, do depose and say as follows:

I am fifty-seven years old and have been a timber cruiser for the last thirty-five years. I saw the section corner common to sections 27, 28, 33 and 34, T.2S., R.9W.W.M., in 1918 while working for the Whitney Co. Ltd. There was one bearing tree remaining with scribes visible on it. It was a dead hemlock stub that beared to the north west from the corner point which I determined from a copy of the original survey notes. I remember an alder that set to the northeast and near the corner, and which is still alive. I returned to the corner in 1926 and 1938, but the bearing tree had decayed away. Richard Morris placed a 1½"x36" galvanized iron pipe with a 3" bronze cap, furnished by the Oregon State Board of Forestry, at the point where the original corner set.
