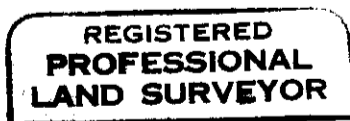

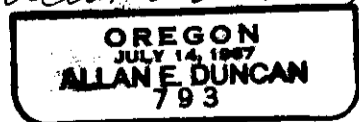

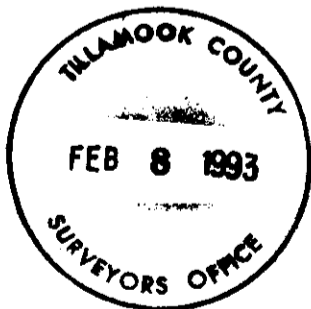
**Location of Monument**

This corner is located 48' West of a house in the roots of a 60" Rotten spruce stump 8' tall.

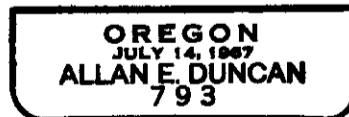
