

RESTORED CORNER OREGON DEPARTMENT OF FORESTRY
4907 Third St., Tillamook, Oregon 97141

One quarter corner common to Sections 21 and 22, T2N, R8W, W.M.,
Tillamook County, Oregon.

ORIGINAL by Henry Meldrum, August 9, 1893.

14"x10"x8" Basalt stone 10" in ground with 1/4 on West face;
not found, point falls under 48" log.

8" Hemlock bears S74E 35 lks.; missing.

20" Hemlock bears S19W 20 lks.; now a 36" x 4 1/2 ft. high
badly rotted stump with scribes 1/4S visible, rest
unexposed.

ERRONEOUS RESTORATION by Louis W. Amort RE 2311 December 8, 1954
(Book 1, page 140, Tillamook County Records).

1 1/2"x36" galvanized iron pipe with 3" bronze cap, 30" in
ground, in mound of stone; pipe leaning, but in place, bears
South 1.32 ft. to BT face.

12" Cedar bears N21E 161.9 ft.; now 35" with face closed.

32" Hemlock bears S02W 60.1 ft.; now 19" x 7 ft. high badly
rotted stub with no scribes or axe work visible.

4"x4"x84" white painted Cedar post 3.0 ft. NE of pipe; in
place.

NOTE: Richard Morris, (Amort's Engineering Aide) apparently
measured 2 lks. from the BT face with a bearing of S19W to the
approximate center of the BT. The distance should have been 20
lks.

RESTORATION October 4, 1994

Var. 19 1/2 E

Set a 5/8" x 36" steel rebar with yellow plastic cap marked
"LS1998", 34 inches in ground, in notch of 48" log and from
which a:

24" Noble fir bears S23 1/2E 50.5 ft. to face; scribed
1/4S22BT.

19" Hemlock bears S89W 6.2 ft. to face; scribed 1/4S21BT.

12" Hemlock bears N52W 32.55 ft. to face; scribed 1/4S21BT.

Amort's 35" Cedar bears N22E 149.2 ft. to approximate
face.

Amort's pipe bears S23W 11.76 ft. with marks "RM ^ LS1998
1994" added.

Amort's 4"x4"x84" white painted Cedar post bears S22W
7.8 ft.

Metal location poster on new BTs.

Also poster on Amort's Cedar BT.

3/4" brass washer marked "LS1998" nailed to face of new BTs.

NOTE: Rebar set from face of original 20" Hemlock which is
consistent with other corners found in this portion of the
township.

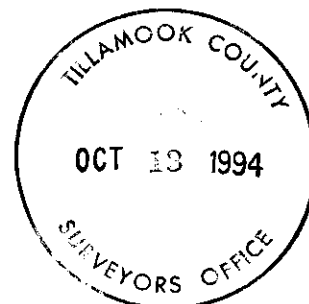
