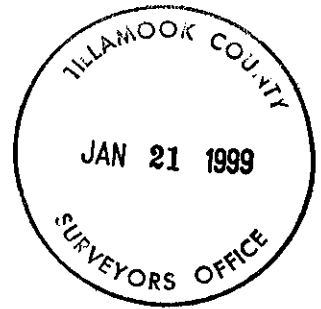

C 1/4 CORNER SECTION 26, T.3S.,R.9W.,W.M.



I FOUND A 1 1/4" X 27" IRON PIPE WITH A WOOD PLUG AND NAIL 1" BELOW THE SURFACE. I SET A 1 1/2" IRON PIPE WITH A 3" TILLAMOOK COUNTY SURVEYORS BRASS CAP IN AN IRREGULAR MASS OF CONCRETE AND STONES, AT THE SAME POSITION AS THE FOUND 1 1/4" IRON PIPE.

**HISTORY OF FOUND MONUMENT**

THERE IS NO RECORD OF THE ORIGIN OF THE FOUND 1 1/4" IRON PIPE, HOWEVER, IT HAS BEEN USED FOR MANY YEARS TO POSITION TRACTS OF LAND IN THE AREA. EVIDENCE SEARCHED FOR OR FOUND IN THE VICINITY IS AS FOLLOWS:

(BOOK 1 PAGE 53) FIR POST FOR CORNER; (NOW GONE).

(BOOK 1 PAGE 53) 8" ALDER N.77°E. 1.06 CHAINS, REPORTED ON MAP F-40-138 AS A 30" ALDER N.77°E. 1.06 CHAINS; (NOW GONE).

(BOOK 1 PAGE 53) 6" FIR S.9°W. 0.71 CHAINS, REPORTED ON MAP F-40-138 AS A 24" FIR S.9°W. 71 LINKS; (NOW GONE).

(NO RECORD) FOUND HAT SECTION POST, 4' HIGH, NORTH 1.2' WITH YELLOW TILLAMOOK COUNTY SURVEYORS LOCATION POSTER ATTACHED, DATED 1968.

\*14" FIR S.73°52'E. 34.24' SCRIBED "BT" ON SMALL LOW FACE.

\*10" FIR S.12°43'W. 34.35' SCRIBED "BT" ON SMALL LOW FACE.

\*26" FIR N.20°48'W. 50.63' SCRIBED "BT" ON SMALL LOW FACE.

\* 4" HEMLOCK S.46°19'W. 8.51' SCRIBED "BT" ON SMALL LOW FACE.

DISTANCES WERE MEASURED TO A T.C.S. BRASS WASHER NAILED BETWEEN THE "B" & "T".

**COMMENTS**

THIS CORNER IS LOCATED APPROXIMATELY 180' SOUTHERLY OF THE CENTERLINE OF BEAVER-BLAINE COUNTY ROAD AND APPROXIMATELY 70' WEST OF A CREEK, 3' WIDE, IN AN OLD FENCE CORNER. REMAINS OF OLD WOOD POST AND BARB WIRE FENCE EAST-WEST. BARB WIRE FENCE WITH STEEL FENCE POSTS RUNS SOUTH FROM THE CORNER. DUE TO THE HIGH VISIBILITY OF THE AREA THE NEW BEARING TREES WERE MARKED WITH SMALL BLAZES AND SCRIBED "BT" ONLY.

THIS REWITNESS WAS MADE TO PRESERVE THIS MONUMENT ONLY. NO ATTEMPT WAS MADE TO VERIFY THE LOCATION OF THIS MONUMENT.

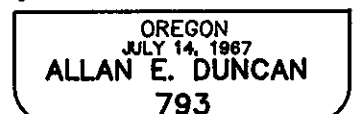
