<p>Previous Rewitnesses, Restorations and Surveys, etc. Map B-904 reports finding 2" pipe with cap and 2 BT's. Rewitness card #850 reports finding brass cap and spruce BT. Rewitness in Book 5, Page 173 and related map B-602 reports setting 2" x 30" GIP with brass cap stamped "T4S R10W W 1/16 S34 S3 T5S R10W 1971 608", with steel post 5.0' south and two BT's as follows: 11" spruce scribed "S34 BT" bears N4-12E 44.10 feet and 40" spruce scribed "S3BT" bears S31-30 E 65.66 feet.</p> <p>Found Monument(s) and Accessories (Condition &amp; Source): I found 2" GIP with 2 1/2" brass cap stamped "1971 T4S R10W W 1/16 S34 S3 T5S 608", top 2" above ground, with orange carsonite post 3.5 feet East and steel post 3.5 feet West ( no evidence of the two bearing trees ).</p>

Other new accessories set: The steel post was loose with sign lying on the ground, I reset at 3.5 feet West and re-attached sign.		
<p>New Bearing Trees: I marked two NEW BT's as follows: 11" spruce with two tops scribed "W 1/16 S34 BT" with brass nail and washer between the B &amp; T bears N 87 E 9.52 feet and 9" fir scribed "W 1/16 S3 BT" with brass nail and washer between the B &amp; T bears S 10 W 9.25 feet. Bearings are hand compass. I nailed a location tag to each bearing tree.</p>		
Location & Comments: The corner lies on a flat approximately 30 feet South of a spur road, approximately 200 feet from the end of the road.
