Found the original 88" diameter Red fir bearing tree, now a 72" diameter 4' tall stump with the scribed 'B' and 'T' still visible, as set by Samuel Snowden on September 15, 1856. This tree was found by Louis W. Amort in 1952 and described as a 72" diameter stump with exposed scribe marks 'B' and 'T' and recorded in Rewitness Book 2, Page 232 and was also found in 2001 by Anthony Klosterman and described as a 72" x 4' tall stump with visible scribe marks 'B' and 'T' and recorded in Rewitness Book 7, Page 334, Tillamook County Survey Records. All of the bearing trees set by Rewitness Book 7, Page 334 are in good condition. There has been approximately a 2" increase in diameter in each of the found bearing trees set by Rewitness Book 7, Page 334.
