Found Monument(s) and Accessories(Condition & Source): Found: 2" iron pipe set by W. E. Anderson on map B-458 (1963) Tillamook County Survey Records. The two accessories set by Anderson a 2" x 2" hub on high bank .7' South of monument and 4" x 4" witness stake not found. A Yellow Metal Location tag was found 1.0' South nailed to fence post, but no reference of origin exists.

Monument Set(Procedures & Description):

Set: 3" Tillamook County Brass cap in concrete, stamped as shown hereon.

The found 2" iron pipe for the West 16th of Sections 30 and 31 was referenced with 2 nails. The monument was dug up and replaced with a 3" diameter Tillamook County brass cap attached to a 1.5" x 30" iron pipe and cement was placed around the monument. A distance-distance measurement was taken from the reference nails to place the new monument's position. The Brass cap is stamped as shown hereon. The average of double occupied GPS observations was obtained for this corner position and the coordinates are provided here in WGS 84, Latitude and Longitude.

Latitude : N 45° 26' 57"
Longitude : W 123° 57' 47"
