History, condition, and sources: In 1873 under G.L.O. contract #183 C.J. Handley D.S. set a wood post for the ¼ corner and gave the corner 2 bearing tree references. Beginning in 1927 with Map A-208 and up to Rewitness card #140 (1979) a stone was used as the corner but no other references other than the G.L.O. references were added. In 1979 Tillamook County Surveyors office set a 2" iron pipe with a 3" Tillamook County brass cap stamped as shown hereon in 10" tile and concrete and added 3 new accessories. In 2022 the Tillamook County Survey office visited the corner and found the cap as shown hereon in good condition but with only one existing accessory the hat section post with yellow metal location tag.


