History, condition, and sources: Samuel D Snowden under GLO contracts 66 and 67 set a post for the quarter section corner common to sections 32 T. 1S, R. 10W and section 5, T.2S, R.10W and referenced 2 bearing trees. In 1889 (Rewitness bk 10 pg71) A.M. Austin set post for corner and added 2 bearing trees. In 1924 (Rewitness bk4 pg31) W.E. Anderson set post for ½ corner and added 2 bearing trees. In 1950 (Rewitness Bk1 pg91) W.E Anderson visited the corner, found one record bearing tree, and added one new one. In 1956 (Rewitness Bk2 pg394) Charles G. Collard found one of Andersons bearing trees down with corner post still attached to root wad. Collard set a ¾" Iron pipe with 1½" babbitted cap stamped "T.1S. T.2S. SEC 5½ R10W SEC 32" as shown hereon. Collard also added two new bearing trees. In 1969 (Rewitness bk3 pg305) Charles Collard visited the corner he had previously set found it to be in good condition and added 2 new bearing trees. In 1978 the Tillamook County Surveyors Office visited the corner added 10" tile around corner monument and filled it with cement along with a hat section post with yellow metal location tag. In 2023 The Tillamook County Surveyors Office found the 1½" babbitted cap surrounded by 10" tile filled with concrete and found 3 record bearing trees as noted below. The Surveyors office also established 2 new bearing trees and installed a new hat section post as described below.
