History, condition, and sources: In ±1857 under G.L.O. contract corner section post was set, and 4 bearing trees were established. In 1887 Hays (HAYS F pg. 72), (Bk. 1, pg. 5) renewed the post and added 4 bearing trees. In 1965 (Bk. 5 pg. 59) 1 ¼" Iron Pipe was found, (probably set by W.E. Anderson on map B-45, see book P5 pg. 52) and 4 new bearing trees were established. In 1976 (Rewitness Card #434) Tillamook County Surveyor Office set a 2" Iron Pipe with a 3" Brass Cap in 10" tile and cement at position of found 1 ¼" Iron Pipe and added a Hat Section Post with corner tag. In 2008 (Bk. 7 pg. 457) Tillamook County Surveyor Office set a new Hat Section Post with a yellow metal location tag 1.5' East of corner monument. The previous Hat Section Post and tag were damaged by falling trees. Four new bearing trees were established. In 2023 (Field Bk. MR 14 pg. 42) Tillamook County Surveyor Office visited the section corner and found a 3" Tillamook County Brass Cap (stamped "T1S R10W S34 S35 S3 S2 T2S R10W 1976 RS 287") in concrete as shown hereon in good condition.

Found: (Rewitness Bk. 7 pg.457) 22" Hemlock S68°E 24.0'. Now 6' tall stump with scribing, yellow metal location tag, and nail with aluminum washer stamped "TILL.CO.SURVEYOR".

Found: (Rewitness Bk. 7 pg. 457) 20" Hemlock S15°W 11.2'. Now 2' tall stump with scribing, and nail with aluminum washer stamped "TILL.CO.SURVEYOR".

Found: (Rewitness Bk. 7 pg. 457) 19" Hemlock N14°E 21.7'. Now 5' tall stump with scribing, and nail with aluminum washer stamped "TILL.CO.SURVEYOR".

Found: (Rewitness Bk. 7 pg. 457) 19" Hemlock N86°W 10.6'. Now 6' tall stump with scribing, yellow metal location tag, and nail with aluminum washer stamped "TILL.CO.SURVEYOR".

Found: (Rewitness Bk. 7 pg. 457) Hat Section Post with yellow metal location tag 1.5' East.

The Monument was tied conventionally using G.P.S. established control. The coordinates have been converted and are provided here in WGS 84, Latitude and Longitude.

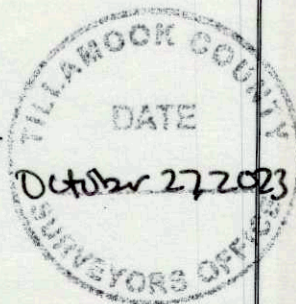
