S. under contract # 500 set a post for the quarter corner common to section 19 and 20 Township 1 south, 9 West Henrey also established 2 bearing trees. In 1888 (bk. 10 pg. 68) set post for 1/4 corner and added 1 new accessory. In 1950 (bk. 4 pg. 69) W.E. Anderson set a 2" iron pipe for the ¼ corner set from an old bearing tree. In 1958 (bk. 10 pg. 69) W.E. Anderson visited the corner and added 2 new accessories. In 1969 (Rewitness card # 212) Tillamook County Survey office found 2" Iron pipe and replaced it with a 3" Tillamook County brass cap marked "R9W 15 % S19 S20 RS287 1969" and added 1 new accessory. In 1999 (rewitness card # 212) Tillamook County survey office visited the corner and added note to rewitness card #212. In 2023 the Tillamook County Survey office visited the corner and found it to be in good condition 1.5' below surface of field.


