**Previous Rewitnesses, Restorations and Surveys, etc...** Original G.L.O. field notebook 2S 10W pg. 8 (1857); Book 10, Page 89 (1892); C-147 (1947); Book 4, Page 55 (1949); Book 3 Page 50 (1964); Rewitness Card #330 and #448 (1971); Book 6, Page 416 (1989).

**History, condition, and sources:** In 1857 under G.L.O. contract number 67 the section corner Post was set and 4 bearing trees were established. In 1892 (Bk. 10, pg. 89) Post was set and 4 new bearing trees were established. In 1947 (C-147) W.E. Anderson set 3/4" Iron Pipe. In 1949 (Bk. 4, pg. 55) W.E. Anderson established 4 new bearing trees with bearings to a 3/4" Iron Pipe. In 1964 (Bk. 3, pg. 50) John L. Carlich set a yellow 2"x 4" 6 inches South of corner for marker. The four previous bearing trees were located, and one new bearing tree was established. In 1969 John L. Carlich replaced the 3/4" Iron Pipe with a 3" Tillamook County Brass Cap (Rewitness Card #330 and #448) Tillamook County Survey Office found 5 bearing trees and 1 rotten stump from a dead bearing tree. 8" tile and cement were set around the found 3" Tillamook County Brass Cap. An 86" Hat Section Post was set 12.8' South. In 1989 (Bk. 6, pg. 416) Tillamook County Survey Office found a 3" Tillamook County Brass Cap in concrete, 5 bearing trees and 1 rotten stump from an old bearing tree. The Hat Section Post was gone so a new 84" Hat Section Post was added 1.5' South. In 2023 (Field Bk. MR 14, pg. 39-40) Tillamook County Surveyor office visited the section corner and found a 3" Tillamook County Brass Cap (stamped "R10W T1S S31 S32 S6 S5 T2S 1969 RS 287") in concrete as shown hereon in good condition. Found white painted 4"x 4" cedar post broken on ground next to monument. All previous bearing trees are now gone. Established four new bearing trees.

Found: white painted 4"x 4" cedar post broken on ground next to monument.

12" Fir scribed "T2SR10WS6BT" with nail and "TILL CO. SURVEYOR" washer between the B&T and yellow metal location tag. S. 63° W. 28.7'

14" Hemlock scribed "T1SR10WS31BT" with nail and "TILL CO. SURVEYOR" washer between the B&T and yellow metal location tag N. 79° W. 25.4'
