History, condition, and sources:

The SE 1/16th corner was first set by Harold Russel RS 707 in 1967 (B-535). He set a 3" Oregon State Board of Forestry brass cap on 1.5-inch galvanized pipe stamped as shown hereon, along with 2 bearing trees and a white painted cedar post. In 2017 (rewitness bk. 8 pg. 73) Terry Jones found the monument in good condition but only the white cedar post remained for a witness marker. He then established 2 new bearing trees. In 2024 the Tillamook County Surveyors Office visited the corner and found the monument to be in good condition up .10' above ground. Listed below are the record accessories for the SE 1/16th corner.


