History, condition, and sources: In ±1872 Contract #166 (BLM Field Note Volume: OR-R0112 Page 085) J. W. Meldrum, Deputy Surveyor set Post with charred stake in mound of earth with pits. In ±1879 Contract # 301 (BLM Field Note Volume: OR-R0180 Page 064) Henry Meldrum, Deputy Surveyor set a 4"x 4" Fir Post and established 2 Bearing Trees. In 1961 (Rewitness Bk. 4 pg. 99) W.E. Anderson reset corner with a 2" Iron Pipe and established 2 Bearing Trees. In 1976 (Rewitness Card #723) Tillamook County Surveyor's Office found a 1 ½" Iron Pipe plugged and tacked set by G.M. and G.A. in 1968. Tillamook County Surveyor's Office set a 2" Iron Pipe with a 3" Tillamook County Surveyor's Brass Cap in 10" tile and cement in position of found 1 ½" Iron Pipe. The two GLO Bearing Trees were gone. The two Bearing Trees set by Anderson were found and a Hat Section Post was added. In 2003 the Hat Section Post was replaced. In 1987 (B-1282) Jim S. Peterson found two Bearing Trees uprooted and established 2 new Bearing Trees. In 1990 (Rewitness Bk. 7 pg. 22) Tillamook County Surveyor's Office set 2 new accessories, a 5/8" x 10" Iron Rod with a red Tillamook County Surveyor's Plastic Cap in the middle of a 29" Spruce stump and a 5/8" x 10" Iron Rod with a red Tillamook County Surveyor's Plastic Cap in the middle of a 22" Spruce stump. In 1992 (B-1628) Leonard A. Rydell found a 3" Tillamook County Surveyor's Brass Cap in concrete, a White Paddle and an Orange Witness Post of unknown origin. In 2024 Tillamook County Surveyor's Office found a 3" Tillamook County Surveyor's Brass Cap in concrete in good condition as shown hereon.




