History, condition, and sources

In December of 2014 (B-3635) Terry Jones set a 1" galvanized iron pipe with a 2 1/2" brass cap stamped "N 1/16 S29 S28 LS 2507 2014" and established four accessories for the corner. In 2024 Tillamook County Surveyor's office visited the corner and found the 2 1/2" brass cap stamped "N 1/16 S29 S28 LS 2507 2014" as shown hereon in good condition. Record accessories are listed below. See field book MR 17 pg. 17 and 18.

- Found: (B-3635 2014) white fiberglass post (East side of monument)
- Found: (B-3635 2014) steel post with metal location tag (East 1')
- Found: (B-3635 2014) 18" spruce scribed "N 1/16 S28 BT" (S45°40'E 9.62') now 20" diameter 6' tall stump with healed scar.
- Found: (B-3635 2014) 18" hemlock scribed "N 1/16 S29 BT" (S51°58' 6.37') now 20" diameter 6' tall stump with healed scar.

New accessories set:

Tied monument directly using GPS in Oregon North Zone NAD 83/91 grid coordinate in US Survey feet. Coordinates provided hereon are given in WGS 84 Latitude and Longitude.

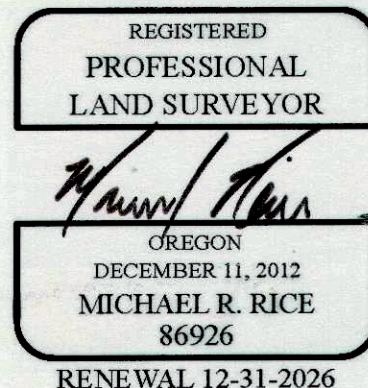
