

**2018/19 GASB 77 - Tillamook County estimated tax to be abated - for disclosure purposes only**

**This only applies for Taxing Districts in Code 9.00 and Code 9.38-see Summary below:**

Tillamook County Assessor & Tax Collector has determined the only abatement that qualifies in Tillamook County are two properties in the Tillamook County String of Pearls Enterprise Zone. Authorization for exemption is per ORS 285C.050-250.

One property is in Levy Code 9.00 and the other property is in Levy Code 9.38.

Code 9.00 Exempt Assessed Value is estimated at \$2,916,440 with \$34,940 estimated tax reduction.

Code 9.38 Exempt Assessed Value is estimated at \$1,511,360 with \$18,106 estimated tax reduction.
