ORDINANCE # 11

AN ORDINANCE ESTABLISHING A FEE SCHEDULE FOR VARIOUS SERVICES AND PURPOSES OF TILLAMOOK COUNTY AS AUTHORIZED BY OREGON REVISED STATUTES AND REPEALING ALL EXISTING ORDINANCES RELATING TO FEES THAT CONFLICT HEREWITH.

THE BOARD OF COUNTY COMMISSIONERS FOR TILLAMOOK COUNTY, OREGON DOES ORDAIN AS FOLLOWS:

ARTICLE I  
INTRODUCTORY PROVISIONS

SECTION 1.010 TITLE

This ordinance shall be known as the Tillamook County Fee Schedule Ordinance.

SECTION 1.020 DEFINITIONS

For purposes of this ordinance "page" means one side of a sheet 13 1/2 inches, or less, long and 8 1/2 inches, or less, wide.

ARTICLE II  
BASIC PROVISIONS

SECTION 2.010 FEES CHARGED AND COLLECTED BY THE COUNTY CLERK

In Tillamook County there shall be charged and collected, in advance, by the County Clerk, for the benefit of Tillamook County, the following fees, and no more, for the following purposes and services.

- 1) The fee for performing the services set forth in ORS 92.090 and 92.100 shall be as follows:
  - a. For approval of any plat by the Board of County Commissioners the Clerk shall collect \$25.00.
  - b. For recording and indexing any plat, the fee collected by the County shall be as follows:
    - I. For plats containing 10 lots or less, \$100.00.
    - II. For plats containing over 10 lots and less than 26 lots, \$150.00.
    - III. For plats containing over 25 lots and less than 51 lots, \$250.00.
    - IV. For plats containing over 50 lots and less than 101 lots, \$5.00 for each lot.
    - V. For plats containing over 100 lots, \$500.00 plus \$3.00 for each lot over 100.

- (2) For purposes of investigating, advertising and otherwise acting on a petition to vacate a public road, street, highway, alley, townsite or portions thereof as set forth in ORS Chapter 271, the County Clerk shall collect, at the time of filing such a petition, a fee of \$70.00.
- (3) For the services of the County Surveyor for marking the record of vacation upon the original plat the County Clerk shall pay over to the County Surveyor a fee of \$5.00.
- (4) For the purposes of investigating and acting on a petition for the vacation of a County Road or portion thereof the County Clerk shall collect, at the time of filing said petition, a fee of \$150.00.
- (5) For all vacation proceedings where the Board of Commissioners requires the petitioners to pay the costs incurred in searching the record for any licenses, franchises or easements in the portion to be vacated the County Clerk shall collect a fee which shall be based on time and materials.
- (6) For the purposes of filing any other petition not set forth herein or in statute the County Clerk shall collect a fee of \$8.50.
- (7) For filing or recording in the official records of Tillamook County any notice, affidavit or other legal document set forth in ORS Chapter 517, the County Clerk shall collect a fee of \$3.50 for each page or the amount set forth in statute as the standard recording fee.
- (8) For issuing a certificate of ownership as set forth in ORS 517.280 the County Clerk shall collect a fee of \$10.00.
- (9) For filing the affidavit relating to the probate of small estates as set forth in ORS 114.515 the County Clerk shall collect a fee of \$25.00, effective October 3, 1979.
- (10) For supplying photographic copies of records, files or other documents to other than private parties the County Clerk shall collect a fee of \$3.00 for locating a record requested by the party and \$0.25 for each page, or the amount set forth in statute as the fee for such services to private parties.
- (11) For the purpose of investigating and acting on an application for liquor license the County Clerk shall collect a fee of \$25.00.

SECTION 2.020 LAW LIBRARY FEES

In Tillamook County, it shall be the duty of the County Clerk to collect in each civil suit, action or proceeding filed in the Circuit Court, a law library fee which shall be 40 percent of the filing fee provided by law. This fee shall be collected in the same manner as other fees are collected in the suit, action or proceeding, and is in addition to the other fees provided by law.

ARTICLE III

MISCELLANEOUS PROVISIONS

SECTION 3.010 SEVERABILITY

The provisions of this Ordinance are severable. If any section, sentence, clause or phrase of this Ordinance is adjudged by a Court of competent jurisdiction to be invalid, the decision shall not affect the validity of the remaining portion of this Ordinance.

SECTION 3.020 ADOPTION AND REPEAL OF CONFLICTING FEES

This Ordinance shall be in force and effect from and after the 6th day of December, 1979, and all previous orders, resolutions, ordinances or other legislation setting fees conflicting with the provisions of this Ordinance are hereby repealed and will be of no further force and effect.
