RESOLUTION

WHEREAS, on April 25, 1978 the Tillamook County House Numbering Ordinance No. 9 was regularly passed and adopted by the County Commissioners of Tillamook County, Oregon, and

WHEREAS, after giving notice by publication of the time and place of hearing, the Tillamook County Planning Commission did on January 29, 1981 conduct a public hearing in the matter of proposed amendment, and

WHEREAS, a report and recommendation were made to the Board of County Commissioners, and said Board of Commissioners having held two public hearings, on March 13, 1981 the other on March 27, 1981 and after due consideration of all evidence presented, FIND:

That it be in the public interest to amend Sections 105.3, 105.4 and 106.1 as shown on Exhibit A. And amend the Grid Map as shown on Exhibit B.

NOW, THEREFORE BE IT RESLOVED, PASSED AND ADOPTED, that Sections 105.3, 105.4 and 106.1 and the Tillamook County Grid Map of the Tillamook County House Numbering Ordinance is hereby amended as shown in Exhibits A and B attached hereto and by its reference made a part hereof.

Exhibit A

- 105.3 Mobile home: means a structure having a minimum of 400 square feet of floor area and transportable in one or more sections on public highways; which may be built on a permanent chassis but is required to be anchored on a permanent foundation when connected to the required utilities; and is designed for use as a residence but which has not been demonstrated to conform to the requirements of the *uniform* building code for other residences. It does not include recreation vehicles i.e., travel trailers, *campers*, or *motor homes*, and is indicated by a Department of Commerce Insignia.
- 105.4 Recreation Vehicle: means a vehicular or portable unit which is either self propelled or towed or is carried by a motor vehicle and which is intended for human occupation and is designed for vacation or recreation purposes but not residential use. *It does include campers, motor homes, or travel trailers.*
- 106.1 The house numbering system for Tillamook County utilizes a grid pattern with each grid line *approximatley* running along the section and half section lines.
