This matter came before the Board of Commissioners for Tillamook County, Oregon, on the 12th day of April, 2017 at the request of Sara Charlton, Tillamook County Librarian. The Board, being fully apprised of the representations of the above-named person, finds as follows:

1. Libraries are not just about what we have for people, but what we do for and with people.
2. Libraries have long served as trusted and treasured institutions, and library workers and librarians fuel efforts to better their communities, campuses, and schools.
3. Librarians are organizers and information experts who for centuries have guided people to the best information resources. Librarians provide more than facts. They provide the expertise and services that add meaning to those facts.
4. Librarians continue to fulfill their role in leveling the playing field for all who seek information and access to technologies, especially as our society is at a critical juncture regarding the changing information landscape and the skills needed to thrive in our digital world.
5. Libraries and librarians open a world of possibilities through innovative STEAM programming, Makerspaces, job-seeking resources, and the power of reading.
6. Libraries and librarians are looking beyond their traditional roles and providing more opportunities for community engagement and for delivering new services that connect closely with patrons' needs.
7. Libraries support democracy and effect social change through their commitment to provide equitable access to information for all library users regardless of race, ethnicity, creed, ability, sexual orientation, gender identity, or socio-economic status.
8. Libraries work to serve all community members, including people of color, immigrants, people with disabilities, and the most vulnerable in our communities, offering services and educational resources that transform communities, open minds, and promote inclusion and diversity.

9. Libraries, librarians, library workers, and supporters across America are celebrating National Library Week.
