This matter came before the Tillamook County Board of Commissioners on June 7, 2017 at the request of Marlene Putman, Health Department Administrator, and the Tillamook County Community Health Council. The Board of Commissioners being fully apprised of the representations of the above-named persons finds as follows:

1. Harry Coffman, Clayton Rees, Carol Fitzgerald, Jessica Galicia, Amy Griggs and Rex Parsons' terms on the Tillamook County Community Health Council expire on June 30, 2017.
2. Harry Coffman and Clayton Rees, representing the community, and Carol Fitzgerald, Jessica Galicia, and Amy Griggs, representing consumers, are qualified and willing to be reappointed as members on the Tillamook County Community Health Council.
3. Timothy Borman, representing the community, is qualified and willing to be appointed as a member on the Tillamook County Community Health Council.
4. The Tillamook County Community Health Council Bylaws revised in November 2012 allow for a new category representation of youth/student members. Youth/student member terms are for one year with up to two additional one-year terms. Terms begin July 1 and end June 30 to coincide with the ending date for regular member terms.
5. Jennifer Arreola is qualified and willing to be appointed as a youth/student member of the Tillamook County Community Health Council.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

6. Harry Coffman and Clayton Rees, representing the community, and Carol Fitzgerald, Jessica Galicia, and Amy Griggs, representing consumers, be and hereby are reappointed to the Tillamook County Community Health Council for three-year terms beginning July 1, 2017 and expiring June 30, 2020.
7. Timothy Borman, representing the community, be and hereby is appointed to the Tillamook County Community Health Council for a three-year term beginning July 1, 2017 and expiring June 30, 2020.
8. Jennifer Arreola, as a youth/student member, be and hereby is appointed to the Tillamook County Community Health Council for a one-year term beginning July 1, 2017 and expiring June 30, 2018.
