This matter came before the Tillamook County Board of Commissioners on January 3, 2018 at the request of Lieutenant Jim Horton, Tillamook County Sheriff's Office. The Board of Commissioners, being fully apprised of the representations of the above-named person, and the records and files herein, finds as follows:

1. The Tillamook County Sheriff's Office currently charges fees for each foreclosure, along with postage and advertising costs on all Writs of Execution in Foreclosure, in accordance with ORS 21.300 for the following items:
 

a. Civil Fee	\$400.00
b. Writs Fee	\$ 70.00
c. Service Fee for pre-sale posting	\$ 36.00
d. Service Fee for post-sale posting	\$ 36.00
e. Advertising Fee	\$208.00
  
2. The Tillamook County Board of Commissioners finds that the following fees will be just, fair, reasonable, and sufficient to provide the proper service to the public:
 

a. Civil Fee (hours, supplies, postage, folio costs)	\$400.00
b. Writ Fee (per statute)	\$ 80.00
c. Service Fee for pre-sale posting (per statute)	\$ 45.00
d. Service Fee for post-sale posting (per statute)	\$ 45.00
e. Advertising Fee (average cost; refunds will be issued when appropriate)	\$230.00
  
3. The Tillamook County Board of Commissioners has the authority to increase fees under ORS 203.010 and ORS 203.115.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

4. The Tillamook County Sheriff's Office charges fees in advance for each Civil Writ of Execution in Foreclosure for the following items:
 

a. Civil Fee (hours, supplies, postage, folio costs)	\$400.00
b. Writ Fee (per statute)	\$ 80.00
c. Service Fee for pre-sale posting (per statute)	\$ 45.00
d. Service Fee for post-sale posting (per statute)	\$ 45.00
e. Advertising Fee (average cost; refunds will be issued when appropriate)	\$230.00
