COUNTY COURT JOURNAL

This matter came before the Tillamook County Board of Commissioners on May 30, 2018 at the request of Sarah Absher, Director, Department of Community Development. The Board of Commissioners being fully apprised of the representations of the above-named person, and records and files herein, finds as follows:

1. The fee schedule set forth in this order has not been revised since November 30, 2011, under Board Order 11-089.
2. The current fee schedule does not accurately reflect the current costs of providing desirable levels of service to the residents and property owners of Tillamook County.
3. The fees for Onsite Sanitation Services need to be increased to improve cost recovery for provision of necessary and required services to process and issue permits.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

4. The fee schedule shall be revised as set forth in the attached Exhibit A, which is incorporated herein by reference as though set forth in full.
5. This order will become effective July 1, 2018.


