This matter came before the Tillamook County Board of Commissioners, sitting as the governing body of the Solid Waste Service District (SWSD), on August 12, 2020, at the request of David McCall, Solid Waste Program Manager, and Chris Laity, P.E., Public Works Director.

The Board of Commissioners, being fully apprised of the representations of the above-named persons, and the records and files herein, finds as follows:

1. During the normal annual review period, Recology Western Oregon requested that any decision about rate changes be delayed until a later time, when things had returned to normal regarding COVID-19.
2. Recology Western Oregon has requested to increase rates charged by a collection franchisee to their customers, effective September 1, 2020.
3. Customer rates for this collector franchisee were last adjusted in Board Order #19-030, SWSD #19-003.
4. The Tillamook County Solid Waste Advisory Committee discussed this request at a special meeting on August 11, 2020.
5. The Tillamook County Board of Commissioners finds that the proposed rates will be just, fair, reasonable, and sufficient to provide the proper service to the public.

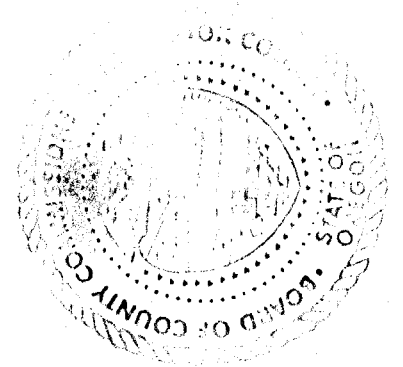
