This matter came before the Tillamook County Board of Commissioners on February 17, 2021 at the request of Chris Laity, Director of Public Works. The Board of Commissioners, being fully apprised of the records and files herein, finds as follows:

1. Tillamook County Public Works acts as the local road authority in accordance with ORS 810.010 and ORS 810.160 and has authorized this action.
2. Tillamook County Public Works received letters of request from Chief James Oeder, Nestucca Rural Fire Protection District, and Wi-Ne-Ma Christian Camp. Both letters request that No Parking signs be installed along both sides of Winema Road from the westerly side of the Wi-Ne-Ma Christian Camp entrance easterly for approximately eighty-five feet (85').
3. For the reasons of public health, safety, and welfare, it is in the interest of the public to establish a No Parking zone for that portion of Winema Road as detailed in Exhibit "A" and Exhibit "B".
4. "Park" or "parking" is defined in ORS 801.380.

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

5. The above-described location be and is hereby declared as a No Parking zone.
6. Tillamook County Public Works Department shall install the appropriate signs for the regulatory zone.
7. Copies of this order shall be sent to the Tillamook County Sheriff and Oregon State Police.

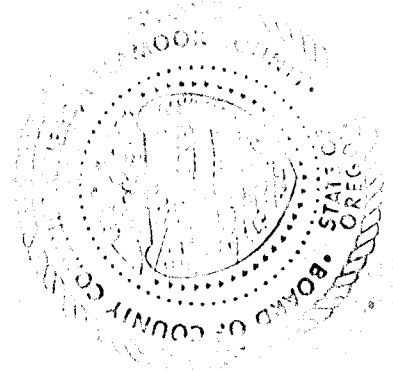
