Campsite allowances and restrictions

<u>Blue Tent Sites</u>: 10-person maximum occupancy; 1 tent and 1 vehicle. 1 additional tent and 1 additional vehicle may be added (fees apply.) 1 recreational vehicle may be substituted in place of 1 tent if the recreational vehicle fits in the campsite driveway. ONLY 1 RECREATIONAL VEHICLE PER BLUE TENT SITE.

Brown Tent Sites: 6-person maximum occupancy; 1 tent and 1 vehicle. No additional tents are allowed in brown campsites. 1 additional vehicle may be added (fee applies.) Barview Jetty County Campground walk-into brown campsites V19 through V26 and W13 through W16 do not have driveways. Park in lot and walk in – No car camping or recreational vehicles permitted at walk-in brown campsites. No recreational vehicles allowed at brown tent sites.

<u>Hiker-Biker Tent Site</u>: 2-person maximum occupancy; 1 tent. No additional tents or vehicles allowed at hiker-biker tent sites; these sites are reserved for people-powered travelers only.

<u>All RV Sites</u>: 8-person maximum occupancy; 1 self-contained recreational vehicle (1 RV and 1 tow vehicle <u>or</u> 1 truck and 1 trailer <u>or</u> 1 overhead truck cab camper and 1 boat, etc.) 1 additional tent and 1 additional vehicle may be added (fees apply.) ONLY 1 RECREATIONAL VEHICLE ALLOWED PER RV SITE.

<u>Cabins</u>: 6-person maximum occupancy. 1 vehicle, no tents. 1 additional vehicle may be added (fee applies.) Pets are allowed in Cabins 1-5 only (fee applies.) No boat trailers or recreational vehicles. No car camping.

Mini Mobile Cabin: 3-person maximum occupancy inside cabin and 5 additional persons allowed in tent at site. 8-person maximum site occupancy; 1 vehicle. 1 tent and 1 additional vehicle may be added (fees apply.) Pets are allowed (fee applies.) No recreational vehicles.

A recreational vehicle is defined as a motorhome, motor coach, travel trailer, truck camper, tent trailer or any other self-contained vehicle used for camping.

Additional vehicles include boat trailers, utility trailers, motorcycles, toy haulers, etc. If it needs to be parked in a parking spot, it is an extra vehicle.

Additional tents include changing tents, toilet tents, child's tents, sleeper vans, and recreational vehicles (one recreational vehicle allowed per site if the recreational vehicle fits into site driveway.)

No exceptions can be made regarding site limitations.

No more than 2 vehicles allowed at any campsite at any given time

ONLY ONE RECREATIONAL VEHICLE IS ALLOWED PER CAMPSITE
